

#### Accommodation

All accommodation suppliers we work with meet as a minimum, the assessment requirements of the School Travel Forum which will include ensuring suppliers have a valid Operating Licence, are in possession of valid indemnity and public liability insurance, and comply with all Local and National Governing Body or Licensing Authority requirements. In addition, our physical assessments cover fire safety arrangements, the existence of an appropriate food management system and general safety areas such as swimming pools and security.

### **Transport**

All transportation suppliers we work with meet as a minimum, the assessment requirements of the School Travel Forum which will include ensuring suppliers have a valid Operating Licence, are in possession of valid indemnity, public liability insurance and transport specific insurances. In addition, where we physically inspect transport suppliers, our assessments cover the management of driver hours & fatigue, driver recruitment, vehicle maintenance and emergency procedures.

Further, all air, rail and sea transportation provided as part of a tour comply with regulations set down by the appropriate Maritime and Coastguard Agency, Civil Aviation Authority or equivalent regulatory body.

#### Please Note:

- Use of/standards of public transport used by groups or individuals during a tour is outside of the control of SkiBound.
- All UK sourced coaches will be provided with seatbelts. Please be aware however it
  is not a legal requirement in many overseas destinations for coaches and buses to be
  fitted with safety restraints.

## **Activities, Ski & Snowsports**

All activities conform to STF guidelines including the completion of relevant STF activity assessment paperwork based on the level of risk of the activity

#### **Emergency Procedures**

- We maintain and regularly test our comprehensive Incident Management Plan, which is separate to but forms part of our Safety Management System, which covers all accident, incident and emergency situations under different incident level classifications dependent on severity.
- Our Incident Management Plan includes arrangements for response to an incident
   24 hours a day.
